Whereas the bulk of the constituency representatives workloads takes place during General Meetings twice a year; and

Whereas there is a variety of constituency work that can and should be done outside of General meeting spaces; and

Whereas during the Annual General Meeting a constituency coordinator is elected to liaise between each of the constituency groups and sits on the Executive Committee; therefore

Be it resolved that the Federation adopt the following composition for a Council of Constituency Representatives within its bylaw; and

Be it further resolved that the Council of Constituency meets a minimum of two times throughout the term to provide updates on the work of the constituency as well as, discuss the ways that the needs of the constituency are reflected within the campaign and advocacy work of the Federation.

Council of Constituency Representatives (CCR)

1. The Council

The Ontario Council of Constituency Representatives shall be known as the Council.

2. Composition

The Council shall be compromised of representative from each constituency group of the Federation. Each constituency group will have one (1) representative per constituency:

- a. Ontario Circle of First Nations, Métis and Inuit Commissioner
- b. Ontario Disability Students Constituency Commissioner
- c. Ontario International Students Constituency Commissioner
- d. Ontario Part-Time and Mature Students Constituency Commissioner
- e. Ontario Queer and Trans Students Constituency Commissioner
- f. Ontario Racialized Constituency Commissioner
- g. Ontario Women's Constituency Commissioner
- h. Ontario Constituency Coordinator

The Council shall also be comprised of the following non-voting members:

- a. Ontario Chairperson
- b. Ontario National Executive Representative
- c. Ontario Treasurer
- 3. Number of votes

Each council representative shall have one (1) vote.

4. Terms of Office of the Council

The term of the office for the positions on the Council shall commence at the close of the Annual General Meeting at which they are elected and shall expire at the close of the subsequent Annual General Meeting.

- 5. Meeting of the Council
 - a. Frequency of Meetings

The Council shall meet at least twice (2) times between regularly scheduled general meetings of the Federation.

b. Quorum

At least fifty-one per cent (51%), but never less than 5 of the voting positions on the Council that are currently filled shall constitute quorum

for the transaction of business. Non-voting positions on the Executive Committee shall not count towards quorum.

c. Notice of Meeting

Formal notice of all Council meetings shall be communicated to each member of the Council no less than ten (10) days before the meeting is to take place. Meetings of the Council shall be held without notice, if all the Council representatives are present, or if those who are absent waive notice, or signify their consent in writing to the meeting being held in their absence.

d. Calling a Meeting

The Council meeting shall be formally scheduled by:

- i. The Council of Constituency Representatives;
- ii. The Ontario Constituency Coordinator, at the discretion in writing of three (3) voting members of the Council.
- 6. Election of the Constituency Council Representatives

The election of each member of the Council shall happen at the Annual General Meeting of the Federation and those positions will start upon the ratification of the results.

7. Filling a vacancy of a Council Representative

In the event that a Council Representative resigns or is removed from office the position will be deemed vacant. A by-election may happen at the Semi- Annual meeting if this vacancy happened before that meeting.

- 8. Eligibility
 - a. A nominee for a position as a Council Representative must be a member of the Federation.
 - b. A nominee for the position must be a delegate at the Ontario Component General Meeting at which the position is being filled.
 - c. A nominee for the position must be nominated by at least two delegates from which constituency group they are running to get elected from.
- 9. Voting Procedure
 - a. Election for each council representative position shall be conducted within each constituency group.
 - b. If no candidate receives a clear majority on the first ballot. There shall be successive ballots and the candidate(s) with the lowest number of votes shall be eliminated from the next ballot until one (1) candidate has a clear majority. Clear majority is fifty percent plus one.
- 10. Remuneration of Council Representatives

Upon completion of office each Council Representative shall receive a remuneration of \$500 on condition that they have demonstrated their participation in a majority of in person meetings, conference calls and other council events. This remuneration does not replace any remuneration a representative receives from sitting on the Ontario Executive.

11. Code of Ethics

Council representatives shall be required to sign the declaration of commitment to the Federation's Code of Ethics in order to be voting members of the Council.

Whereas to meet the criteria for approval of existing funding for students with disabilities, such as the Canada Student Grant for Students with Permanent Disabilities, the Canada Student Grant for Services and Equipment for Students with Permanent Disabilities, and the Ontario Bursary for Students with Disabilities, students must often pay costly assessment fees up front, and endure a complicated, and time-consuming application process, which pose effective barriers to post-secondary education enrolment; and

Whereas these difficulties may exacerbate the discomfort, ill-health, and stress

experienced by many students with disabilities; and

Whereas application processes are made more difficult to navigate for part-time students with disabilities; and

Whereas part-time students with disabilities may not be eligible for funding because they may be following a part-time or reduced course-load due to, or in part due to their disabilities; therefore

Be it resolved that the Federation conduct an investigation into the Federal and Provincial funding available for students with disabilities with an emphasis on the frameworks for funding students with disabilities on a part-time or reduced course-load; and

Be it further resolved that this investigation aim to discover and identify the bureaucratic "red tape" (e.g.: instances of duplication of collection of information); the costs (or potential costs) students with disabilities must shoulder to meet criteria (e.g.: cost of specialist assessment); the number of steps, appointments and amount of personal time required to meet criteria; and who should qualify but does not quite meet the criteria and why (e.g.: who is slipping through the cracks?); and

Be it further resolved that the Federation prepare a report on the findings so that members of the Federation can discuss solutions and lobby government on behalf of part-time students with disabilities; and

Be it further resolved that an update on the findings be reviewed and discussed at the Executive Committee meeting in October 2017 and the final report presented to members at the Semi-Annual General meeting in January 2018.

Whereas member locals representing part-time and/or continuing education students ensure that their respective institutions collect Federation fees from their members based upon a pro-rate of Federation fees for full-time students; and

Whereas each part-time and/or continuing education association may have a different method and rationale for calculating the pro-rate for their members based upon institutional constraints, course credit values, or other criteria, which result in differences in the amounts collected per course or per member; and

Whereas there may be times when member locals lose continuity due to turnover of personnel and board members, and therefore, the institutional memory needed to ensure the pro-rate is properly calculated; and

Whereas in the event of a miscalculation on the part of member locals, it may not be possible to levy or reimburse individual members once the fees have been collected from them for a given term, and may result in undue costs or time consumption for member

locals; and

Whereas each February the Federation provides a letter with the breakdown of the fees and a per semester dollar amount for full-time students for the following school year; and

Whereas the Federation does not provide a similar breakdown for member locals representing part-time and/or continuing education students; and

Whereas there are only four member locals representing part-time and/or continuing education students; therefore

Be it resolved that the Federation provide each member local representing part-time and/or continuing education students with a yearly breakdown of the fees to charge their respective members, including the rationale for the charge and the dollar amount per semester beginning February 2018; and

Be it further resolved that in the event of a miscalculation of fees on the part of any member local (part-time, continuing education, or full-time), the Federation will provide timely communication, and work together with the affected local to determine an appropriate solution or course of action.

Whereas Culture Camp Forever is a camp that is teaching Indigenous people Traditional Knowledge and teaching the Ojibwe language. It is free to anyone who would like to attend. They are teaching people how to live off the land and building cottages for people who plan to occupy Crown land. The camp is located by Elliott Lake in Ontario; and

Whereas this is a grassroots initiative to resist Canada 150 and that Indigenous water protectors such as Isaac Murdoch, Christie Belcourt and others have organized. There is Elders of various communities as well as language and knowledge keepers that are volunteering their time and knowledge to strengthen our Indigenous youth and bring culture/language back into their lives. The camp is mainly using the Anishnaabe language to run the camp; and

Whereas the Culture Camp is running purely off of donations and will not be requesting nor accepting government funding; and

Whereas Culture Camp Forever has made a request to have food items donated to the camp to feed the residents that will be participating in building a traditional community. They have asked for large bags of rice and porridge; and

Whereas the donation could be used to buy snacks for children and elders such as granola bars, various snacks and juice boxes; therefore

Be it resolved that the Federation donate \$500 to purchase various food items to send to the camp; and

Be it further resolved that the Federation purchase these items for the camp or grocery cards rather than sending a cheque; and

Be it further resolved that member locals be encouraged to send donations as well.

Be it further resolved that the Federation prepare and distribute a survey in spring 2018 on student issues to the leaders of the major political parties, and make their responses public.

The survey questions include but are not limited to:

- Do you support free, universal post-secondary education for every student in Ontario?
- What will you do to address the crisis of student debt in Ontario?
- What will you do to address the crisis of precarious work that youth in Ontario face?
- What steps will you take to specifically address high youth unemployment and underemployment among young workers to ensure access to jobs in a variety of fields?
- What measures would you support to address sexual and gender-based violence on college and university campuses?

Be it further resolved that member locals be encouraged to send a copy of the same survey to candidates in their local ridings and to make members aware of their responses.

Whereas the *Fight for \$15 and Fairness* campaign has been organizing across the province in workplaces, on campuses, and in community spaces, to demand government action to raise the provincial minimum wage to \$15/hour, and to improve employment standards; and

Whereas the campaign previously won indexation legislation in 2014 to ensure that workers receive wage adjustments each year on October 1 to reflect increases in the Consumer Price Index; and

Whereas the campaign has elevated the voices of students and workers and has won victories such as Unite Here Local 75's successful strike in Spring 2017 for a \$15/hour starting wage and full health and dental coverage for part-time and full-time workers; and

Whereas on June 1, 2017, the Ontario government tabled The Fair Workplaces, Better Jobs Act, 2017 (Bill 148) which proposes an increase to the adult general minimum wage to \$15/hour within 18 months, equal pay for equal work between full-time, part-time, casual and temporary workers, extension of job-protected, emergency leave to all workplaces, two paid (out of ten) emergency leave days, three weeks of paid vacation (after five years of service), and easier access to unionization; and

Whereas the Bill, if adopted, will increase the hourly wages of 1.5 million workers currently earning less than \$15/hour which would provide substantial benefits in the lives of students and workers; and

Whereas corporate lobbyists are working against the victories of the *\$15 and Fairness* campaign, and are preparing to launch a major fear-mongering campaign in Fall 2017 through mass media; and

Whereas the *Fight for \$15 and Fairness* will need resources in order to push back against the corporate onslaught and to prevent the best aspects of Bill 148 from being rolled-back; and

Whereas the Federation endorsed the *\$15 and Fairness* campaign and continues to support Ontarians working for low wages in precarious jobs without employment benefits, workplace protection or the right to form and keep a union; therefore

Be it resolved that the Federation mobilize to strengthen Bill 148 and support removing the sub-minimum wage rates for students under 18 and liquor servers that would remain unchanged in the Bill as it is currently written, and support the review of minimum wage exemptions in the Ministry of Labour's promised Fall 2017 review; and

Be it further resolved that the Federation support the campaign's recommendation to revoke amendment s.3(5)2 in Bill 148 which adds an exclusion from ESA protections for an individual who performs work under a private career college registered under the Private Career Colleges Act, 2005; and

Be it further resolved that the Federation donate \$2000 to support the efforts of the *\$15* and *Fairness* campaign and create a social media campaign that would help members understand the economic and social benefits of increasing the provincial minimum wage to \$15/hour; and

Be it further resolved that each Federation local be encouraged to donate at least \$500 from their campaigns budgets to support a *\$15 and Fairness* Campus Assembly, a gathering of student organizers on September 15, 2017, in Toronto, and that each local be encouraged to send at least one or two members to the Assembly.

Whereas student unions/federations/associations employ full-time staff and part-time staff that are not covered by the institution's policy and/or their associated workers unions' policy; and

Whereas there has been recent changes to the Canadian Criminal Code regarding the practices of how to respond to and handle sexual violence cases; and

Whereas within the Federation policies, the section entitled "Sexual Assault and Violence Against Women on Campus" supports policies, practices and education that are proactive in addressing sexual violence on campuses; therefore

Be it resolved that member locals of the Federation are to each develop an internal sexual violence policy to include full-time staff, part-time staff, and elected positions; and

Be it resolved that each Federation member local is encouraged to review their completed sexual violence policy every five years; and

Be it further resolved it is suggested that each Federation member local create a working group consisting of all affected parties at their organization to assist in the creation of their sexual violence policy; and

Be it further resolved that any member local with a standing internal sexual violence policy is recommended to undergo a full review of said policy alongside recent federal and provincial recommendations and requirements; and

Be it further resolved that each Federation member local is recommended to have a sexual violence policy developed by the August 2018 Federation AGM; and

Whereas Ontario universities and colleges are now required by the Ontario Government via Bill 132 to have or update their Sexual Violence Policies. The Canadian Federation of Students, Ontario is a federation of student unions/federations/associations from varying universities and colleges that collectively work in unison on behalf of students and does not currently have a sexual violence policy for its members; and

Whereas the Federation employs full-time staff and is in direct contact with students from member locals that are not covered by a Federation sexual violence policy; and

Whereas the Federation hosts meetings and spaces where various member locals interact. The Federation needs to have its own sexual violence policy for such spaces under its jurisdiction; and

Whereas the Federation sexual violence policy would be used in cases where the parties involved are from different member locals, who are attending Federation hosted meetings and spaces, who would therefore be covered by this Federation sexual violence policy, instead of being covered by their own local union/federation/association sexual violence policy that could create difficulty in reaching a conclusion for the Federation; and

Whereas within the Federation policies, the section entitled "Sexual Assault and Violence Against Women on Campus" supports policies, practices and education that are proactive in addressing sexual violence on campuses; therefore

Be it resolved that the Federation develop an internal sexual violence policy to include fulltime staff, part-time staff, elected positions, and member local delegates attending any of their meeting/events; and

Be it resolved that the Federation is recommended to review their completed sexual violence policy every five years; and

Be it further resolved that it be suggested that the Federation creates a working group consisting of representatives of affected parties at their organization to assist in the creation of their sexual violence policy; and

Be it further resolved that the Federation is encouraged to have a sexual violence policy developed by the August 2018 Federation AGM; and

Be it further resolved that the Federation is encouraged to a provide progress report at January 2018 Ontario Semi-AGM and a final report at August 2018 AGM, upon completion.

Whereas the Fight for \$15 and Fairness will need resources in order to push back against the corporate onslaught and to prevent the best aspects of Bill 148 from being rolled-back; and

Council of Constituency Representatives (CCR)

1. The Council

The Ontario Council of Constituency Representatives shall be known as the Council.

2. Composition

The Council shall be compromised of representative from each constituency group of the Federation. Each constituency group will have one (1) representative per constituency:

- a. Ontario Circle of First Nations, Métis and Inuit Commissioner
- b. Ontario Disability Students Constituency Commissioner
- c. Ontario International Students Constituency Commissioner
- d. Mature Students Constituency Commissioner
- e. Ontario Queer and Trans Students Constituency Commissioner
- f. Ontario Racialized Constituency Commissioner
- g. Ontario Women's Constituency Commissioner
- h. Ontario Constituency Coordinator

The Council shall also be comprised of the following non-voting members:

- a. Ontario Chairperson
- b. Ontario National Executive Representative
- c. Ontario Treasurer
- 3. Number of votes
 - Each council representative shall have one (1) vote.
- 4. Terms of Office of the Council

The term of the office for the positions on the Council shall commence at the close of the Annual General Meeting at which they are elected and shall expire at the close of the subsequent Annual General Meeting.

- 5. Meeting of the Council
 - a. Frequency of Meetings

The Council shall meet at least twice (2) times between regularly scheduled general meetings of the Federation.

b. Quorum

At least fifty-one per cent (51%), but never less than 5 of the voting positions on the Council that are currently filled shall constitute quorum for the transaction of business. Non-voting positions on the Executive Committee shall not count towards quorum.

c. Notice of Meeting

Formal notice of all Council meetings shall be communicated to each member of the Council no less than ten (10) days before the meeting is to take place. Meetings of the Council shall be held without notice, if all the Council representatives are present, or if those who are absent waive notice, or signify their consent in writing to the meeting being held in their absence.

d. Calling a Meeting

The Council meeting shall be formally scheduled by:

- i. The Council of Constituency Representatives;
- ii. The Ontario Constituency Coordinator, at the discretion in writing of three (3) voting members of the Council.
- 6. Election of the Constituency Council Representatives

The election of each member of the Council shall happen at the Annual General Meeting of the Federation and those positions will start upon the ratification of the results.

7. Filling a vacancy of a Council Representative

In the event that a Council Representative resigns or is removed from office the position will be deemed vacant. A by-election may happen at the Semi-Annual meeting if this vacancy happened before that meeting.

- 8. Eligibility
 - a. A nominee for a position as a Council Representative must be a member of the Federation.
 - b. A nominee for the position must be a delegate at the Ontario Component General Meeting at which the position is being filled.
 - c. A nominee for the position must be nominated by at least two delegates from which constituency group they are running to get elected from.
- 9. Voting Procedure
 - a. Election for each council representative position shall be conducted within each constituency group.

- b. If no candidate receives a clear majority on the first ballot. There shall be successive ballots and the candidate(s) with the lowest number of votes shall be eliminated from the next ballot until one (1) candidate has a clear majority. Clear majority is fifty percent plus one.
- 10. Remuneration of Council Representatives

Upon completion of office each Council Representative shall receive a remuneration of \$500 on condition that they have demonstrated their participation in a majority of in person meetings, conference calls and other council events. This remuneration does not replace any remuneration a representative receives from sitting on the Ontario Executive.

11. Code of Ethics

Council representatives shall be required to sign the declaration of commitment to the Federation's Code of Ethics in order to be voting members of the Council.
