Be it further resolved that the Federation lobby the government for additional support for students who are living with mental health issues, as well as encourage member locals to lobby their local Members of Parliament; and

Be it further resolved that the Federation and member locals demand accountability from the government and individual institutions regarding the issuing and use of government funding for mental health programs; and

Be it further resolved that the Federation initiate research on the major mental health issues affecting students in post-secondary education; and

Whereas students at northern postsecondary institutions face specific challenges which exacerbate those faced by students across Canadian postsecondary institutions, including increased distance from social supports and isolation from family and friends, increased costs of living associated with northern residency, and the higher likelihood of origin in low-income communities; and

Whereas students at northern post-secondary institutions have expressed their need to have reasonable breaks from academic classes during both the fall and winter terms, in order to draw on social supports through traveling to visit family and friends.

Be it resolved that the Issues Policy on "Mental Health" be amended to read:

# MENTAL HEALTH

#### Preamble

Students adapting to a post-secondary institution need to adjust to significant changes, including but not limited to moving to a new area, separation from family and friends, establishing a new social network, managing a budget given the realities of high tuition fees, combining academic study with other commitments, coping with access in a new environment and, for international students, living in a new country and adjusting to a different culture. For students attending northern institutions, these challenges are intensified with regard to distance from family and friends, fewer options for intercity transit, and with regard to increased financial, employment, and housing pressures. Moreover, students for whom English or French is not their first language may have additional difficulty expressing mental health issues and engaging with mental health services on their campus. While these changes can be exciting and challenging and an intrinsic part of the attraction of going to university or college, they can also give rise to anxiety and stress.

Students may face challenges, experience stress and/or a personal crisis, which without appropriate supports inhibit their ability to participate fully in higher education. These difficulties may take the form of long-term or temporary, but debilitating mental health conditions. In addition, some students may arrive at university or college with a pre-existing psychological condition, either declared or undeclared.

Mental health issues can seriously impair academic performance and overall behaviour. Minor difficulties that interfere with a student's capacity to work may also result in distress and undermine academic progress. Post-secondary institutions have a responsibility to provide adequate services and support to promote the mental wellness of students, staff, faculty and other members of their community.

### Policy

The Federation supports mental health strategies that:

- Utilize on-campus committees mandated to investigate mental health services and ensure adequate delivery of quality service. These committees should be comprised of representatives of the institution, students' union representatives, student group representatives, faculty associations and staff unions;
- Recognize the diversity of experiences faced by students in post-secondary institutions;
- Consider the impacts of high tuition fees and un/underemployment on students' mental health;
- Adequately fund and provide resources for campus mental health and counselling services, including crisis and trauma centers;
- Work to destigmatize mental health issues within the student population and promote a culture of safety in discussing these issues;
- Respect the confidentiality of personal information provided by students and service-users;
- Recognize the unique needs of northern students; and
- Recognize the need for both fall and winter breaks to allow students time to travel to draw on critical social supports of family and friends.

Be it resolved that the Issues Policy on "Northern Students' Issues" be amended to read:

#### NORTHERN STUDENTS' ISSUES

#### Preamble

For a variety of reasons, northern colleges and universities require additional supports, over and above those offered to other institutions, in order to provide high quality post-secondary education. There are a variety of government funding programs that continue to predicate the receipt of public dollars upon the successful leveraging of private resources to co-finance the research and teaching activities of Ontario's colleges and universities. Such programs have impacted programs ranging from student financial aid to research and capital projects. These programs continue to disadvantage northern institutions that do not often have the endowments, program mix or access to financial centres that are required to maximize matched-funding models.

In addition, students and families who reside in northern and rural regions of Ontario also face barriers that are unique from those faced by students in the southern part of the province and large municipalities. Northern Ontario is home to a significant number of Aboriginal and francophone communities as compared to the rest of Ontario that face particular educational barriers. In general, students who study in the north have to contend with higher prices for commodities, longer commuting distances, lower vacancy rates, fewer employment opportunities and lower than average wages. As a result, people who are from northern communities are more likely to live in poverty and less likely to have access to college or university education. Furthermore, many students attending northern post-secondary institutions face increased pressures on their mental health with regard to ability to access critical social supports through visiting family and friends. It is within this context that the impact of the province's current policy of high fees and high debt must be considered.

# Policy

The Federation supports:

- Increased funding for Ontario Distance Grants;
- Measures to be taken by the Ontario Student Assistance Program (OSAP) to take into account the extra expenses incurred by students who attend a post-secondary education institution in northern Ontario;
- An increase in funding to expand the number of upper year French and Indigenous-language courses offered;
- A specific grant for all Aboriginal students who attend college or university;

- Funding to guarantee the availability of public student residence spaces beyond the first-year;
- An increase in funding to expand graduate studies in northern Ontario, with the emphasis on doctoral programs and graduate studies in French and Indigenous languages;
- A credit transfer system that mandates that credits earned in French and Indigenous programs be accepted for equivalent credits at English-language institutions;
- Full passenger rail and bus service in northern Ontario;
- Investments in research and innovation that contribute to the sustainability of the northern Ontario economy including the natural resource and mining sectors;
- The continued development of a wider variety of professional programs in Northern Ontario;
- Increased funding and support for First Nations culture and language programs;
- The construction of Leadership in Energy and Environmental Design (LEED) standard buildings, in an effort to reduce the environmental impact of capital efforts in northern Ontario; and
- Increased funding and support for mental health initiatives in northern Ontario.

The Federation opposes:

- The migration of entire programs from northern institutions to satellite campuses located in southern Ontario;
- The continued freeze of Northern and Extraordinary Grants;
- The use of satellite campuses as a mechanism strictly used to meet budgetary and/or enrolment projections;
- The phasing out of face-to-face instruction by other means; and
- Differentiation initiatives in northern post-secondary institutions.

Whereas the Carleton University Board of Governors is proposing changes to the Board Bylaws which would change the eligibility requirements to hold office as a Governor; and

Whereas the proposed eligibility restrictions would exclude members of the executive of a student association from being eligible to hold office as a Governor; and

Whereas undergraduate and graduate students at Carleton (members of Local 1 and Local 78, respectively) have a long history of electing their student union executives as their representatives to the Board; and

Whereas student union executives are the legitimate and democratic representatives of students, are accountable to their constituencies, and have the resources and knowledge to effectively represent students at the Board level; and

Whereas a survey of thirteen universities across Ontario shows that these proposed restrictions are highly unusual, as only Queen's University restricts student association executives from sitting on the Board of Trustees; and

Whereas the Board is also proposing to impose similar restrictions upon the executives and officers of unions representing faculty and staff of the university, who would also be deemed ineligible to sit on the Board; and

Whereas the Board is also proposing to remove the right of student unions to nominate their representatives to the Board, giving the university the ability to control all elections; and

Whereas the Board is also proposing to restrict access to the Board by banning all members of the Carleton community from observing Open Meetings without explicit invitation from the Secretary; and

Whereas these proposed Bylaw changes reduce the opportunities for students, faculty, and staff at Carleton to participate in the affairs of the university, and undermine the ability of their associations to effectively represent and serve their members; therefore

Be it resolved that a letter be written to the Carleton University Board of Governors condemning the proposed Bylaw changes as an attack on student and labour representation; and

Be it further resolved that member locals be encouraged to write similar letters.

Whereas the current structure hinders the ability of some delegates to socialize and make meaningful connections with fellow student-movement activists; and

Whereas the Federation strives to be a progressive voice pushing for accessible education in all forms and is currently developing a campaign on student mental health issues, requiring us to be reflexive of our own practices and the ways they may perpetuate systemic ableism; therefore

Be it resolved that the Provincial Executive evaluate the structure of, and develop strategies for the restructuring of, the AGMs to ensure greater accessibility; and

Be it further resolved that the Provincial Executive implement any changes as soon as possible and provide a report on its findings.

Whereas the Council of Ontario Universities and university administrations are increasingly adopting and popularizing the concept of "net tuition"; and

Whereas "net tuition" is a concept that distinguishes between the so-called "sticker price" of education versus "what students actually pay," intending to suggest that tuition is not actually a significant cost after all available scholarships, grants, and other forms of financial assistance are taken into account; and

Whereas the concept of "net tuition" relies on a series of assumptions that distort the reality of students, which is that post-secondary education is increasingly unaffordable; and

Whereas grants and financial assistance programs, including the 30% tuition rebate offered by Ontario, do not make up for rising tuition costs, especially as many students are ineligible for those programs; and

Whereas the real cost of education is actually much higher than the "sticker price" of tuition when you take into account living expenses, textbooks, transportation, and other costs; and

Whereas "net tuition" does not take into account the high levels of student debt; and

Whereas the concept of "net tuition" does not provide a better understanding of the affordability of post-secondary education, but merely obfuscates the real issues and justifies tuition fee increases by governments and universities; therefore

Be it resolved that a resource be developed that clearly outlines the problems with the concept of "net tuition," and that will assist locals in pushing back against the use of the concept by government officials and university administrations.

Whereas these days of action have been criticized for ending abruptly, and not providing space for our student movement to grow beyond days of action; and

Whereas in Quebec student unions and public sector labour unions will be having actions against austerity starting in mid-October and probably continuing into November; therefore

Be it resolved that the Federation have a day of action on November 4 where student unions can hold rallies, walkouts, sit-ins, and more calling for a freeze, reduction, and elimination of tuition fees in Ontario, an end to the differentiation process and budget cuts at universities, and stand in solidarity with the Quebec movement against austerity; and

Be it further resolved that the Federation encourage mobilization/action committees and local student unions to participate in these actions; and Be it further resolved that the Federation plan for a second day of action on February 10 with the same demands; and

Be it further resolved that the Federation hold debriefs, both immediately after each action, and at the Winter and Summer general meetings, for student union executive and activists to discuss how we can improve actions in the future and to strategize on how we can continue momentum in our escalating action plan.

#### Preamble

Racism is a form of oppression based on the social, political, economical and historical construction of race and power that affects the lived experiences of all people, including students. Racism historically is implemented through verbal, psychological, and physical discrimination or harm. Today racism is also systemically manifested in institutions like governments, educational institutions, the criminal justice system and other large organizations that have the power to detrimentally influence the lives of many.

Although the Federation's findings in the Racialized Impact of Tuition Fees identify economic barriers as the "most significant hindrance to equal access to postsecondary education," the report indicates "discriminatory practices serve to prevent equitable access to universities and colleges." The report confirms that racialized people "find themselves as lower income earners on average, and census data demonstrates that average undergraduate tuition fees are a high percentage of the average income earnings of visible minorities than non-visible minorities." Furthermore, the Federation's findings from the Task Force on Campus Racism conclude that "instances of racism and racial discrimination are not isolated; discrimination toward racialized students, faculty and staff is a systemic feature of Ontario's post-secondary education system."

Racism in the criminal justice system also detrimentally impacts the lives of our members. High profile reports such as the 2005 Kingston Data Collection Project, The 2015 Region of Peel and United Way Report on the Consultations into the Well-Being of Black Youth in Peel Region, The Special Report in human rights and racial profiling in the 2013/14 Ontario Human Rights Commission Annual Report, the 2002 Toronto Star analysis of Toronto Police statistics have reported that residents of racialized origins receive harsher treatment than white residents, and are overrepresented in police statistics of charges and arrests. Students attending post-secondary education experience racism in the following forms: harassment and interrogation by the Canadian Security Intelligence Service (CSIS), police brutality and killings, discriminatory treatment based on association or membership in a particular student club or organization, and restrictions on travel based on race, ethnicity or country of origin. Many of our members who are recent immigrants and refugees arriving in Canada are increasingly from racialized communities. They must have the confidence that they would not face discrimination from police or other security and government services both on and off campus.

### Policy

The Federation supports:

- Access to an affordable education free from explicit and systemic forms of racism;
- Advocacy and support resources on campuses dedicated to combatting systemic forms of racism and creating safer and accessible spaces for racialized students;
- Diverse student representation on governing bodies of post-secondary institutions;
- Diverse representation of racialized communities in front-line student support services and resources;
- The work of all member locals and community groups that seek to eliminate racism in post-secondary education, the criminal justice system, and other public institutions; and
- All equity-based institutional initiatives that seek to correct the historical injustices of the past and create a level playing ground for racialized students.

The Federation opposes:

- Explicit and systemic racism in campus life;
- Institutional racism in hiring practices and curriculum; including but not limited to: racist micro-aggressions, differential pay based on race, the censorship of issues related to racism from class curricula and publishings;
- Systemic racism in institutional policy and governance;
- Systemic racism in the broader society;
- Discrimination and harassment from police or other security and government services both on and off campus;

- The ongoing criminalization of racialized communities through increased surveillance and disproportionate incarceration rates of racialized communities; and
- The increased surveillance and criminalization of campus groups representing racialized communities.

# RACIAL PROFILING AND CARDING

#### Preamble

Racial profiling and the current carding protocols used by law enforcement have significant and negative impacts on specific members of the Canadian population including black and brown youth, and racialized immigrants from marginalized communities. These members are being specifically being targeted and criminalized by law enforcement as they are subjected to random carding and searches. Racial profiling is based on stereotypical assumptions because of one's race, colour, ethnicity, etc.

Carding and racial profiling from law enforcement continues to have severe negative impacts on racialized individuals, ranging from mental health issues, trauma, and police brutality in many cases throughout Ontario. The police carding tactics continue to send especially more black and brown youth into jails and penitentiaries, which continues to work in line with Canada's prison-industrial complex. Criminal profiling,

on the other hand, relies on actual behaviour or on information about suspected activity by someone who meets the description of a specific individual, rather than relying on stereotypes, according to the Ontario Human Rights Commission (OHRC).

Law enforcement, specifically like that of the Toronto Anti-Violence Intervention Strategy (TAVIS), a branch of the Toronto Police Services (TPS), Ontario Provincial Police (OPP), and the Harper Administration play a crucial role in on going institutionalized racial discrimination in certain communities. Many carding interactions are not about gathering intelligence, rather about amassing personal details of innocent civilians. Black people and to a lesser extent brown people are disproportionately subjected to this unethical police practices. For example, the ratios of young black males documented and carded in Zone 523 in Toronto is 252:1. For brown young males, the ratio is 65:1, and for young white males the ratio is 23:1.

Institutionalized racism and xenophobic actions of Canada as a state has to be seen in a holistic scope as it is occurring all across Ontario and Canada. Bill C-51, Canada's latest addition to the "Anti-terrorism Act," is an Act of the Parliament of Canada that amends over a dozen Canadian laws, including the Criminal Code, to permit Canadian government agencies to share information about individuals easily. Bill C-51 also gives more broad powers and widens the mandate of the Canadian Security Intelligence Service (CSIS) and many other law enforcement agencies in Canada. Bill C-51 will make it easier for government agencies to share information about carded individuals more easily and impede of the human rights and freedoms and privacy of all peoples by creating a context for the implementation of racial profiling.

Many students, specifically racialized students attending post-secondary education have experienced racial profiling in the form of international students being denied access to college or university based on their country of origin, interrogation by the Canadian Security Intelligence Service (CSIS) on campus, interrogation in their organizing circles or differential treatment based on membership in a particular campus club or organization, and restrictions on travel based on race, ethnicity or country of origin.

# Policy

The Federation supports:

- The right to live without harassment from law enforcement and the state as a whole;
- Accessible education for all students regardless of race, colour, ethnicity, ancestry, religion, country of origin or citizenship;
- The right to security of the person and to personal privacy for all peoples; and
- Freedom from discrimination.

The Federation opposes:

- The ongoing carding and racial profiling practises of law enforcement which are mandated by the state
- Marginalized students from certain countries being denied entrance to Canadian universities and colleges based on their race, colour, ethnicity, ancestry, religion, country of origin or citizenship;
- The presence of law enforcement and security intelligence on university and college campuses to interrogate students based on their race, colour, ethnicity, ancestry, religion, country of origin or citizenship;
- University and college administrations granting law enforcement access to student records such as library loan records and research interests;

- Black and Brown youth facing more stringent security measures than those who are not racialized;
- The imposition of stricter regulations on the activities of certain campus clubs and student organizations based on their race, colour, ethnicity, ancestry, religion, country of origin or citizenship;
- The encouragement of campus police to pay close attention to particular students based on race, colour, ethnicity, ancestry, religion, country of origin or citizenship; and
- The encouragement to get police stations on campus, which will result in more carding and racial profiling of racialized students and civilians.

Whereas according to a series of investigative reports done by the Toronto Star in 2013, people stopped for the sake of "engagement" between 2008 and 2013 were more likely to be African-Canadian than white and the majority of encounters did not involve an arrest or charges; and

Whereas the institutionalized racism and xenophobic actions of the state must be seen in a holistic scope as it is occurring all around Ontario and negatively affects not only youth, but whole communities, further adding to the Canadian prison-industrial complex; and

Whereas not only has the Federation written policies specific to combatting racism and racial profiling, but it also represents students and members that face racial profiling on constant basis; and

Whereas this also falls in line with the Federation Task Force on Campus Racism which was created in 2008, providing recommendations on how to improve campuses to become spaces free of racism and discrimination; and

Whereas we are representatives of the Federation in our member locals and we play a fundamental role in combatting racial profiling and carding in our respective communities; and

Whereas we are obligated to seek advice from community groups and on-campus groups who actively combat racial profiling on our campuses and neighboring communities on daily basis; therefore

Be it resolved that the Canadian Federation of Students-Ontario write a letter to the Toronto Police Chief Mark Saunders and Toronto Mayor John Tory regarding their condoning of malicious acts of racism and xenophobia through racial profiling and carding; and

Be it further resolved that a letter be written to the Premier Kathleen Wynne and the Liberal government urging them to condemn racial profiling and carding; and

Be it further resolved that member locals continue to combat racial profiling and carding by providing unconditional support and seeking advice from any community groups and oncampus groups who actively organize against racial discrimination, racial profiling and carding in their respected neighborhoods; and

Be it further resolved that upon receiving advice from community groups, that the Canadian Federation of Students-Ontario develop a campaign and produce materials to combat racial profiling and carding in our communities.

- Triple the application fee price;
- · Remove a person's right to appeal a negative citizenship decision;

• Strip the right to an oral hearing in front of a judge for those who are having their citizenship revoked (it will make so this decision is made by a bureaucrat without holding a hearing);

• Strip citizenship from those who did not obtain citizenship by birth if an official believes that the person never intended to live in Canada; and

• Strip citizenship from dual citizens even if they were born in Canada if convicted of certain crimes, even if those convictions occurred outside Canada; therefore

Whereas counseling and support services on campuses across Ontario are often underresourced, inadequate, and are inaccessible to many students; and

Whereas those living with mental health issues are often delayed in completing their studies and face additional financial barriers due to insufficient or poor quality mental health services on campus; and

Whereas post-secondary institutions in the province have seen dramatic decreases in public funding resulting in cuts to counseling and support services available to students on campus; and

Whereas students at Northern Institutions face additional barriers to education which affect their mental health; and

Whereas as the Ontario Graduate Caucus recently launched the "Not in the Syllabus" campaign to gather information from graduate students related to bullying, harassment and mental health issues; therefore

Be it resolved that the Canadian Federation of Students-Ontario conduct research on existing mental health support programs and funding from the government and individual institutions; and

Be it further resolved that the Federation lobby the government for additional support for students who are living with mental health issues, as well as encourage member locals to lobby their local Members of Parliament; and

Be it further resolved that the Federation and member locals demand an increase in public funding and accountability from the government and individual institutions regarding the issuing and use of government funding for mental health programs; and

Be it further resolved that the Federation initiate research on the major mental health issues affecting students in post-secondary education; and

Whereas the Carleton University Board of Governors is proposing changes to the Board Bylaws which would change the eligibility requirements to hold office as a Governor; and

Whereas the proposed eligibility restrictions would exclude members of the executive of a student association from being eligible to hold office as a Governor; and

Whereas undergraduate and graduate students at Carleton (members of Local 1 and Local 78, respectively) have a long history of electing their student union executives as their representatives to the Board; and

Whereas student union executives are the legitimate and democratic representatives of students, are accountable to their constituencies, and have the resources and knowledge to effectively represent students at the Board level; and

Whereas a survey of thirteen universities across Ontario shows that these proposed restrictions are highly unusual, as only Queen's University restricts student association executives from sitting on the Board of Trustees; and

Whereas the Board is also proposing to impose similar restrictions upon the executives and officers of unions representing faculty and staff of the university, who would also be deemed ineligible to sit on the Board; and

Whereas the Board is also proposing to remove the right of student unions to nominate their representatives to the Board, giving the university the ability to control all elections; and

Whereas the Board is also proposing to restrict access to the Board by banning all members of the Carleton community from observing Open Meetings without explicit invitation from the Secretary; and

Whereas these proposed Bylaw changes reduce the opportunities for students, faculty, and staff at Carleton to participate in the affairs of the university, and undermine the ability of their associations to effectively represent and serve their members; therefore

Be it resolved that a letter be written to the Carleton University Board of Governors condemning the proposed Bylaw changes as an attack on student and labour representation; and

Be it further resolved that member locals be encouraged to write similar letters; and

Be it further resolved that member locals provide information to the Federation through the provincial executive committee to conduct a democracy audit of universities and colleges across the province to assess the level of student participation and influence in the policy making and governing procedure at campuses across Ontario; and

Be it further resolved that within the audit, member locals provide information on international student representation on their respective Board of Governors; and

Be it further resolved that the democracy audit be used to develop a report card that grades the quality of academic governance of universities and colleges in Ontario.

Whereas grants and financial assistance programs, including the 30% tuition rebate offered by Ontario, do not make up for rising tuition costs, especially as many students are ineligible for those programs; and

Whereas the real cost of education is actually much higher than the "sticker price" of tuition when you take into account living expenses, textbooks, transportation, and other costs; and

Whereas "net tuition" does not take into account the high levels of student debt; and

Whereas the concept of "net tuition" does not provide a better understanding of the affordability of post-secondary education, but merely obfuscates the real issues and justifies tuition fee increases by governments and universities; therefore

Be it resolved that a resource be developed that clearly outlines the problems with the concept of "net tuition," and that will assist locals in pushing back against the use of the concept by government officials and university administrations.

Whereas racial profiling and carding in our neighbourhoods continue to heavily impact marginalized and racialized communities, and on a more frequent basis than non-racialized areas; and

Whereas specifically black and brown youth, and racialized immigrants in our communities are being targeted and criminalized by law enforcement and are subjected to random carding and searches; and

Whereas the police are using the guise of "community engagement" to move forward with the notion of racial profiling and carding; and

Whereas the effects of racial profiling and carding can range from mental health issues to trauma and violence by the police; and

Whereas the Toronto Anti-Violence Intervention Strategy (TAVIS) branch of the Toronto Police Services (TPS), Ontario Provincial Police (OPP) play a critical role in institutionalized racial discrimination, in addition to the Harper Administration, particularly with the implementation of Bill C-51 and Bill C-24; and

Whereas Toronto's Mayor John Tory formally stated that he was against police carding but after newly appointed chief of Police Mark Saunders stated that he will continue to implement the policy of carding, Mayor John Tory retracted his statement informally and sent the policy to be reformed at the provincial level; and

Whereas according to a series of investigative reports done by the Toronto Star in 2013, people stopped for the sake of "engagement" between 2008 and 2013 were more likely to be African-Canadian than white and the majority of encounters did not involve an arrest or charges; and

Whereas the institutionalized racism and xenophobic actions of the state must be seen in a holistic scope as it is occurring all around Ontario and negatively affects not only youth, but whole communities, further adding to the Canadian prison-industrial complex; and

Whereas not only has the Federation written policies specific to combatting racism and racial profiling, but it also represents students and members that face racial profiling on constant basis; and

Whereas this also falls in line with the Federation Task Force on Campus Racism which was created in 2008, providing recommendations on how to improve campuses to become spaces free of racism and discrimination; and

Whereas we are representatives of the Federation in our member locals and we play a fundamental role in combatting racial profiling and carding in our respective communities; and

Whereas we are obligated to seek advice from community groups and on-campus groups who actively combat racial profiling on our campuses and neighbouring communities on daily basis; therefore

Be it resolved that the Canadian Federation of Students-Ontario write a letter to the Toronto Police Chief Mark Saunders and Toronto Mayor John Tory regarding their condoning of malicious acts of racism and xenophobia through racial profiling and carding; and

Be it further resolved that a letter be written to the Premier Kathleen Wynne and the Liberal government urging them to condemn racial profiling and carding; and

Be it further resolved member locals write a letter to their local MPP to urge them to take a position and condemn racial profiling and carding and continue to combat racial profiling and carding by providing unconditional support and seeking advice from any community groups and on-campus groups who actively organize against racial discrimination, racial profiling and carding in their respected neighbourhoods; and

Be it further resolved that upon receiving advice from community groups, that the Canadian Federation of Students-Ontario develop a campaign and produce materials to combat racial profiling and carding in our communities.

Whereas establishing alliances and coalitions with the labour movement is an important mechanism to strengthen our movement for social change; and

Whereas the Federation and its member locals need to find and utilize different opportunities to educate and build awareness about the current and continuing crisis of

public post-secondary education and the upfront barriers that greatly impact racialized communities and people with disabilities; therefore

Be it resolved that member locals be strongly encouraged to attend local labour meetings and district labour councils as guests, observers and where possible seek affiliate membership to participate in the local labour council; and

Be it further resolved that member locals be supported by the Executive and staff of the Federation to make presentations at their local district labour councils in the area of the member local, and that presentations occur prior to the federal election to raise awareness about the lack of funding for post-secondary education and the erosion of universities and colleges as a public service; and

Be it further resolved that a template PowerPoint be provided to member locals to present at labour councils and ensure consistency in messaging on the current crisis in postsecondary education, and that this presentation includes: information on the historical context of federal funding to demonstrate the shift and decline in government funding, and how the cost of post-secondary education is a barrier to racialized, Aboriginal communities and people with disabilities; and

Be it further resolved that the Federation also provide resource materials and research to member locals including but not limited to: research on how high fees further systemic racism, sexism, and ableism faced by students currently in post-secondary education and potential students.

Whereas the Canadian Federation of Students publicly condemned the corporate rightwing attacks and the use of scab labour by the Employer at Crown Metal Packaging Ltd that forced the unionized employees of United Steelworkers (USW) local 9176 to be on strike for almost two years; and

Whereas the Employer forced the workers to be on strike and continued to use scab labour that prolonged the strike and further that the employer threatened to only offer a tentative deal if all the current workers and union organizers could be terminated from their current employment; and

Whereas the Federation supported the striking workers at USW local 9176 to raise awareness about this issue and supported the boycott of canned beer and partnered to create and distribute "Bottles Not Cans" coasters; and

Whereas the USW local 9176 reached a tentative deal on July 9, almost 22 months after being on strike but the financial hardship of the local and these workers will have a long-term devastating impact; therefore

Be it resolved that the Federation make a contribution to the United Steelworkers (USW) local 9176 hardship fund in the amount of \$300; and

Be it further resolved that the Federation send a letter of solidarity to the President and Recording Secretary of USW local 9176 to acknowledge the long and devastating strike that occurred over 21 months as a result of their American scab employer Crown Metal Packings Limited.

# 2015/08:056 MOTION

Whereas Bill C-24, the Strengthening Canadian Citizenship Act will:

- · Make it much more difficult to obtain citizenship;
- · Make obtaining citizenship more expensive;
- · Replace Judges as decision makers with Immigration officers; and
- · Make it easier for citizenship to be revoked or stripped from Canadians; and

Whereas Bill C-24 will also:

• Extend the costly language test to include those aged 14 - 64 (currently, only those aged 18 - 55 take the test);

• Give Immigration officers authority to deny citizenship if they so much as speculate that the applicant may not reside in Canada in the future;

• Increase the residency requirement during which an applicant must be in Canada as a Permanent Resident from 3 to 4 years and does not allow the applicant to count any of the time spent in Canada prior to obtaining permanent residency;

- Triple the application fee price;
- · Remove a person's right to appeal a negative citizenship decision;

• Strip the right to an oral hearing in front of a judge for those who are having their citizenship revoked (it will make so this decision is made by a bureaucrat without holding a hearing);

• Strip citizenship from those who did not obtain citizenship by birth if an official believes that the person never intended to live in Canada; and

• Strip citizenship from dual citizens even if they were born in Canada if convicted of certain crimes, even if those convictions occurred outside Canada; therefore

Be it resolved that member locals be encouraged to lobby their local Member of Parliament and candidates in the upcoming federal elections to commit to repeal amendments to the *Citizenship Act* or any other consequential amendments to other Acts (short title: *Strengthening Canadian Citizenship Act*) that empower the government to introduce barriers in the way of obtaining Canadian citizenship: and allowing the government to arbitrarily strip persons of this status as morally, legally and ethically wrong; and

Be it further resolved that members be encouraged to collaborate with coalition partners through a campaign to condemn the amendments as described in the *Strengthening Canadian Citizenship Act.*

Whereas Bill C-51 will undermine our basic rights and put every Canadian at risk of having their private information collected and stored in government databases; and

Whereas Bill C-51 has been described as reckless - the bill has a vague definition of terrorism that could be abused by governments and spy agencies to shut down dissent; and

Whereas Bill C-51 has been described as dangerous - the bill would shred our privacy by allowing information gathered through widespread spying on Canadians to be shared broadly within government. It would also give CSIS new powers to intervene in the day to day life of Canadians, with actions that could break the law and violate the *Charter of Rights and Freedoms*; and

Whereas Bill C-51 has been described as ineffective - the bill fails to use proven counterradicalization strategies, and contains no proper oversight to prevent abuses; and

Whereas Canada's privacy commissioner Daniel Therrien has warned, in particular, about the information-sharing aspect of C-51; and

Whereas on Feb. 23, 2015, a group of more than 100 academics wrote an open letter outlining five specific concerns with C-51, including concerns over privacy rights and freedom of speech; and

Whereas the Conservative controlled House of Commons and Senate just passed Bill C-51 despite massive opposition from hundreds of thousands of everyday Canadians and the country's top privacy experts; therefore

Be it resolved that member locals be encouraged to lobby their local Member of Parliament and candidates in the upcoming federal elections to commit to repeal Bill C-51, a bill that empowers the government to enact a new security intelligence informationsharing statute of vast scope with no enhanced protections for privacy and from abuse; and

Be it further resolved that members be encouraged to collaborate with coalition partners through a campaign to condemn Bill C-51.

Whereas additive approaches concludes universal experiences for marginalized communities; and

Whereas equity and anti-oppression trainings at the general meetings discuss white privilege; and

Whereas adding intersectional approaches to the equity and anti-oppression trainings create productive spaces for unlearning; therefore

Be it resolved that the Canadian Federation of Students-Ontario update their equity material so that it explicitly acknowledges and discusses intersectionality; and

Be it further resolved that the Provincial Executive committee explore opportunities and/or spaces for discussion on intersectionality within general meetings; and

Be it further resolved that intersectionality and the understanding of decolonization is used as a basis for the equity and anti-oppression trainings.

Be it further resolved that member locals be encouraged to support calls to action in the report and educate their membership about the history of colonialism in Canada and the importance of following the Truth and Reconciliation Commission's recommendations using tactics such as outreach and organising workshops, panels and/or other events; and

Be it further resolved that in the spirit of Truth and Reconciliation that the *Challenge Colonialism* material for the *United for Equity* campaign recognizes Canada as a settler state which profits off of Indigenous and racialised communities.

Whereas students are under unprecedented attack with Ontario having the highest tuition fees in the country and post-secondary education institutions across Ontario implementing budget cuts under the differentiation framework; and

Be it resolved that the federation and its member locals organize a day of action, prior to the federal election on October 19 2015 against austerity and cuts to public services where member locals can hold campus actions that could include: rallies, teach-ins, walkouts, sit-ins, or demonstrations that demand funding for public services and direct funding for post-secondary education from the federal government to ensure a reduction and elimination of tuition fees; and

Be it further resolved that pending the outcome of the federal election the Ontario Executive recommend further appropriate mobilization and escalated actions for member locals to continue to demand direct funding to elimination of tuition fees; and

Be it further resolved that with the support of the CFS Ontario Executive, member locals participate in a teleconference meeting to debrief after the day of action and also after the outcome of the federal election, towards planning a day of action in winter 2016 and that this meeting be open to member local executive members, staff and activists to discuss how to improve on actions in the future and how to escalate this plan to demand the elimination of tuition fees.

Be it further resolved that this session be held in the form of, but not limited to: a panel discussion, anti-oppression training, workshop or facilitated discussion.

Whereas the Federation strives to be a progressive voice pushing for accessible education in all forms and is currently developing a campaign on student mental health issues, requiring us to be reflexive of our own practices and the ways they may perpetuate systemic ableism; therefore

Be it resolved that the Provincial Executive evaluate the structure of, and develop strategies for the restructuring of, the AGMs to ensure greater accessibility; and

Be it further resolved that the Provincial Executive implement any short-term changes as soon as possible and provide a report on long-term recommendations at the next general meeting.

Whereas this is a major stride against gender-based discrimination in Canada, the prices for these products remain high, and thus attainment of these products prove to be an issue for women, girls, and the trans community who come from low-income households; and

Whereas, although a natural bodily function, requires the need for proper feminine hygiene products in order for menstruating individuals to be able to continue their daily activities uninterrupted; and

Whereas a failure to have access to these products not only prevents them full functionality of their week due to a natural process that they are forced to undergo, but in addition, the profits made from the Canadian government of these highly priced essential products targeted specifically to menstruating individuals can be seen as being both gender based exploitation of the female body, as well as classist based discrimination of low-income families; and

Whereas the proposal for free feminine hygiene products is designated to label tampons, pads, and menstrual cups as non-luxury items, and to distribute these products free of charge within our university/ college campuses; therefore

Be it resolved that the Federation look into the feasibility of providing member locals with tampons, menstrual cups and pads to provide to students; and

Be it further resolved that the Federation provide a report of its findings at the next January 2016 Semi-Annual General Meeting.

# 2015/08:010 MOTION TO AMEND ISSUES POLICY

Local 32/Local 41

Whereas students at northern postsecondary institutions face specific challenges which exacerbate those faced by students across Canadian postsecondary institutions, including increased distance from social supports and isolation from family and friends, increased costs of living associated with northern residency, and the higher likelihood of origin in low-income communities; and

Whereas students at northern post-secondary institutions have expressed their need to have reasonable breaks from academic classes during both the fall and winter terms, in order to draw on social supports through traveling to visit family and friends.

Be it resolved that the Issues Policy on "Mental Health" be amended to read:

# MENTAL HEALTH

## Preamble

Students adapting to a post-secondary institution need to adjust to significant changes, including but not limited to moving to a new area, separation from family and friends, establishing a new social network, managing a budget given the realities of high tuition fees, combining academic study with other commitments, coping with access in a new environment and, for international students, living in a new country and adjusting to a different culture. For students attending northern institutions, these challenges are intensified with regard to distance from family and friends, fewer

options for intercity transit, and with regard to increased financial, employment, and housing pressures. Moreover, students for whom English or French is not their first language may have additional difficulty expressing mental health issues and engaging with mental health services on their campus. Lastly, students who are marginalized may experience minority stress and as a result face additional barriers. While these changes can be exciting and challenging and are intrinsic parts of the attraction of going to university or college, they can also give rise to anxiety and stress.

Students may face challenges, experience stress and/or a personal crisis, which without appropriate supports inhibit their ability to participate fully in higher education. These difficulties may be long-term or temporary but nonetheless debilitating for students' mental health. In addition, some students may arrive at university or college with a pre-existing psychological condition, either declared or undeclared.

Mental health issues can seriously impair academic performance and overall wellbeing. Minor difficulties that interfere with a student's capacity to work may also result in distress, undermine academic progress and compromise academic success. Postsecondary institutions have a responsibility to provide adequate services and support, and to raise awareness to promote the mental wellness of students, staff, faculty and other members of their community.

### Policy

The Federation supports mental health strategies that:

- Utilize on-campus committees mandated to investigate mental health services and ensure delivery of quality service. These committees should be comprised of representatives of the institution, students' union representatives, student group representatives, faculty associations and staff unions;
- Recognize and address the diversity of experiences faced by students in postsecondary institutions;
- Prioritize the representation of individuals with lived experience of mental health barriers who may be able to significantly contribute to the discussion to improve mental health services on campus;
- Recognize the impact of racism, xenophobia, sexism, homophobia, transphobia, ableism, colonialism and other forms of oppression on the mental health of members of marginalized communities;
- Recognize the unique needs of mature and part-time, graduate, and distance education students as well as students operating outside of a first-language context;
- Recognize the unique needs of northern students;
- Recognize the need for both fall and winter breaks to allow students time to travel to access and draw on personal means of support;
- Address the impacts of high tuition fees, underemployment, unemployment and precarious employment on students' mental health;
- Adequately fund and provide resources for campus mental health and counselling services, including crisis and trauma centers;
- Work to destigmatize mental health issues within the student population and to promote safe spaces to address these issues;
- Respect the confidentiality of personal information provided by students and service-users;
- Are jointly funded and administered by the Ministry of Health and Long-Term Care, the Ministry of Training, Colleges and Universities, and/or individual institutions; and

Acknowledge and respect traditional ways of spiritual healing.

Whereas students attending post-secondary institutions in northern Ontario face increased pressures which exacerbate mental health challenges; and

Whereas differentiation in post-secondary institutions negatively impacts northern students, in that northern students have additional limitations in accessing a wide range of programs within a large region and a diverse population; therefore

Be it resolved that the Issues Policy on "Northern Students' Issues" be amended to read:

#### **NORTHERN STUDENTS' ISSUES**

#### Preamble

For a variety of reasons, northern colleges and universities require additional supports, over and above those offered to other institutions, in order to provide high quality post-secondary education. There are a variety of government funding programs that continue to predicate the receipt of public dollars upon the successful leveraging of private resources to co-finance the research and teaching activities of Ontario's colleges and universities. Such programs have impacted initiatives ranging from student financial aid to research and capital projects. These programs continue to disadvantage northern institutions that do not often have the endowments, program mix or access to financial centres that are required to maximize matched-funding models.

In addition, students and families who reside in northern and rural regions of Ontario also face barriers that are distinct from those faced by students in the southern part of the province and large municipalities. Compared to the rest of the province, Northern Ontario is home to a significant number of Aboriginal and francophone communities that face particular educational barriers. In general, students who study in the north have to contend with higher prices for commodities, longer commuting distances, lower vacancy rates, fewer employment opportunities and lower than average wages. As a result, people who are from northern communities are more likely to live in poverty and less likely to have access to college or university education. Furthermore, many students attending northern post-secondary institutions face increased pressures on their mental health with regard to ability to access personal means of support. It is within this context that the impact of the province's current policy of high fees and high debt must be considered.

#### Policy

The Federation supports:

- Increased funding for Ontario Distance Grants;
- Measures to be taken by the Ontario Student Assistance Program (OSAP) to take into account the extra expenses incurred by students who attend a post-secondary education institution in northern Ontario;
- An increase in funding to expand the number of upper-year French and Indigenous-language courses offered;
- A specific grant for all Aboriginal students who attend college or university;
- Funding to guarantee the availability of public student residence spaces beyond the first year;

- An increase in funding to expand graduate studies in northern Ontario, with the emphasis on doctoral programs and graduate studies in French and Indigenous languages;
- A credit transfer system that mandates that credits earned in French and Indigenous programs be accepted for equivalent credits at English-language institutions;
- Full passenger rail and bus service in northern Ontario;
- Investments in research and innovation that contribute to the sustainability of the northern Ontario economy including the natural resource and mining sectors;
- The continued development of a wider variety of professional programs in Northern Ontario;
- Increased funding and support for Aboriginal culture and language programs;
- The construction of Leadership in Energy and Environmental Design (LEED) standard buildings, in an effort to reduce the environmental impact of capital projects in northern Ontario; and
- Increased funding and support for mental health initiatives in northern Ontario.

The Federation opposes:

- The migration of entire programs from northern institutions to satellite campuses located in southern Ontario;
- The continued freeze of Northern and Extraordinary Grants;
- The use of satellite campuses as a mechanism strictly used to meet budgetary and/or enrolment projections;
- The phasing out of face-to-face instruction by other means; and
- Differentiation initiatives in northern post-secondary institutions.

# RACISM

### Preamble

Racism is a form of oppression based on the social, political, economic and historical construction of race and power that affects the lived experiences of all people, including students. Racism works to disadvantage racialized people and further advantage members of the dominant group. It is historically implemented through verbal, psychological, and physical discrimination or harm. Today, racism is also systemically manifested in institutions like governments, educational institutions, the criminal justice system and other large organizations that have the power to detrimentally influence the lives of many.

Although the Federation's findings in the Racialized Impact of Tuition Fees identify economic barriers are as the most significant hindrance to equal access to postsecondary education, the report indicates "discriminatory practices serve to prevent equitable access to universities and colleges." The report confirms that racialized people "find themselves as lower income earners on average, and census data demonstrates that average undergraduate tuition fees are a high percentage of the average income earnings of visible minorities than non-visible minorities." Furthermore, the Federation's findings from the Task Force on Campus Racism conclude that "instances of racism and racial discrimination are not isolated; discrimination toward racialized students, faculty and staff is a systemic feature of Ontario's post-secondary education system."

Racism in the criminal justice system also detrimentally impacts the lives of our members. High profile reports such as the 2005 Kingston Data Collection Project, The 2015 Region of Peel and United Way Report on the Consultations into the Well-Being of Black Youth in Peel Region, The Special Report in human rights and racial profiling in the 2013/14 Ontario Human Rights Commission Annual Report, the 2002 Toronto Star analysis of Toronto Police statistics have reported that residents of racialized identities receive harsher treatment than white residents and are overrepresented in police statistics of charges and arrests. Students attending post-secondary institutions experience racism in the following forms: harassment and interrogation by the Canadian Security Intelligence Service (CSIS), police brutality and killings, discriminatory treatment based on association or membership in a particular student club or organization, and restrictions on travel based on race, ethnicity or country of origin. Many of our members who are immigrants and refugees arriving in Canada are increasingly from racialized communities. They must have the confidence that they will not face discrimination from police or other security and government services both on and off campus.

# Policy

The Federation supports:

- Access to education free from overt, covert and systemic forms of racism;
- Advocacy and support resources on campuses dedicated to combatting systemic forms of racism as well as creating safer and accessible spaces for racialized students;
- Diverse student representation on governing bodies of post-secondary institutions;
- Diverse representation of racialized communities in front-line student support services and resources;
- The work of all member locals and community groups that seek to eliminate racism, particularly anti-black racism, in post-secondary education, the criminal justice system, and all other institutions; and
- All equity-based institutional initiatives that seek to correct the historical injustices and create equitable conditions for racialized students.

The Federation opposes:

- Overt, covert and systemic racism in campus life;
- Institutional racism in hiring practices and curriculum; including but not limited to: racist micro-aggressions, differential pay based on race and the censorship of issues related to racism from class curricula and publishings;
- Systemic racism in institutional policy and governance;
- Systemic racism in the broader society and global community;
- Discrimination and harassment from police or other security and government services both on and off campus;
- The ongoing criminalization of racialized communities through increased surveillance and disproportionate incarceration rates of racialized community members; and
- The increased surveillance and criminalization of campus groups representing racialized communities.

## 2015/08:036 MOTION TO AMEND ISSUES POLICY

Local 68/ Local 41

Be it resolved that the issues policy on "Racial Profiling" be repealed and replaced with the following:

## **RACIAL PROFILING AND CARDING**

#### Preamble

Racial profiling and the current carding protocols used by law enforcement have significant and negative impacts on specific members of the Canadian population including black and brown youth, and racialized immigrants from marginalized communities. These members are disproportionately targeted and criminalized by law enforcement as they are subjected to random carding and searches. Racial profiling is based on stereotypical assumptions because of one's race, colour, ethnicity, etc.

Carding and racial profiling from law enforcement continues to have severe negative impacts on racialized individuals, ranging from mental health issues, trauma, and police brutality in many cases throughout Ontario. The police carding tactics continue to send especially more black and brown youth into jails and penitentiaries, which continues to work in line with Canada's prison-industrial complex. Criminal profiling, on the other hand, relies on actual behaviour or on information about suspected activity by someone who meets the description of a specific individual, rather than relying on stereotypes, according to the Ontario Human Rights Commission (OHRC).

Law enforcement, specifically like that of the Toronto Anti-Violence Intervention Strategy (TAVIS), a branch of the Toronto Police Services (TPS), Ontario Provincial Police (OPP), Canadian Security and Intelligence Service (CSIS) and the Royal Canadian Mounted Police (RCMP) play a crucial role in on going institutionalized racial discrimination in certain communities. Many carding interactions are not about gathering intelligence, rather about amassing personal details of innocent civilians. Black people and to a lesser extent brown people are disproportionately subjected to unethical police practices. For example, the ratios of young black males documented and carded in Zone 523 in Toronto is 252:1. For young brown males, the ratio is 65:1, and for young white males the ratio is 23:1.

Institutionalized racism and xenophobic actions of the Canadian state have to be seen in a holistic scope as they are occurring across Ontario and Canada. The Anti-Terrorism Act of 2015 amends over a dozen Canadian laws, including the Criminal Code, to permit Canadian government agencies to share information about individuals easily. The Anti-Terrorism Act of 2015 also gives more broad powers and widens the mandate of the Canadian Security Intelligence Service (CSIS) and many other law enforcement agencies in Canada. The Anti-Terrorism Act of 2015 makes it easier for government agencies to share information about carded individuals and violates human rights and freedoms and privacy of all peoples by creating a context for the implementation of racial profiling.

Many students, specifically racialized students attending post-secondary education, have experienced racial profiling in the form of international students being denied access to college or university based on their country of origin, interrogation by the Canadian Security Intelligence Service (CSIS) on campus, interrogation in their organizing circles or differential treatment based on membership in a particular campus club or organization, and restrictions on travel based on race, ethnicity or country of origin.

### Policy

The Federation supports:

- The right to live without harassment from law enforcement and from other state agents;
- Accessible education for all students regardless of race, colour, ethnicity, ancestry, religion, country of origin or citizenship;
- The right to security of the person and to personal privacy for all peoples; and
- Freedom from discrimination.

The Federation opposes:

- The ongoing state-mandated carding and racial profiling practises of law enforcement;
- Marginalized students being denied entrance to Canadian universities and colleges based on their race, colour, ethnicity, ancestry, religion, country of origin or citizenship;
- The presence of law enforcement and security intelligence on university and college campuses to interrogate students based on their race, colour, ethnicity, ancestry, religion, country of origin or citizenship;
- University and college administrations granting law enforcement access to student records such as library loan records and research interests;
- Black and Brown youth facing more stringent security measures than those who are not racialized;
- The imposition of stricter regulations on the activities of certain campus clubs and student organizations based on their race, colour, ethnicity, ancestry, religion, country of origin or citizenship;
- The focus of campus police on particular students based on race, colour, ethnicity, ancestry, religion, country of origin or citizenship; and
- The presence of police stations on campus, which will result in more carding and racial profiling of racialized students and other civilians.

# DOOR-TO-DOOR MAIL DELIVERY

## Preamble

The Canada Post Corporation Act of 1981 contains a mandate to provide mail services in a reliable manner and to ensure the corporation's financial security and independence.

Canadians rely upon affordable door-to-door mail services throughout the year. On December 11, 2013, with the support of the federal government, Canada Post announced drastic cutbacks to our public postal service, designed to eliminate door-to-door mail delivery for 5.1 million Canadian households, as well as significantly increase the cost of postage. Canada Post is a public service and crown corporation therefore these cuts are a clear attack on our public postal service. A cut of door-to-door mail service negatively and disproportionately impacts seniors and persons with disabilities. Hundreds of mayors have complained about the decision to cut door-to-door delivery, and Hamilton and Montreal have already launched their own legal challenges.

## Policy

The Federation supports:

- Public services that are publicly funded, maintained and supported by unionized workers;
- The establishment of fair and reasonable postage rates;
- Accessible delivery of mail for rural and urban communities;
- Postal service practices that reinforce ecological sustainability;
- The implementation of postal banking to serve rural and urban communities;
- Substantive public consultation on any changes to the postal service;
- Respect, fairness and decent working conditions for public servants employed at Canada Post; and
- The continuation of Canada Post as a public service.

Whereas the SIU, Ontario's Special Investigations Unit doesn't track race-based data in deaths of black people; and

Whereas black people are targeted more now than during the Jim Crow era; and

Whereas these instances of anti-black racism exist in communities across Ontario; and

Whereas BLMTO responded to the murder of Eric Garner following the no-indictment verdict by holding a die-in at Yonge and Dundas; and

Whereas BLMTO responded to the murder of Toronto-native Jermaine Carby by holding a rally at police headquarters and holding a sit in at the U.S. consultant; and

Whereas BLMTO joined the community by holding a vigil for the murder of Andrew Loku, a 45 year old refugee who was a student at George Brown who suffered PTSD from being a child soldier; and

Whereas BLMTO created a list of demands to hold Mayor John Tory, Police Chief Mark Saunders and the Toronto Police accountable for the murders of black people in the city; and

Whereas when the demands weren't met BLMTO and the community occupied and shut down both sides of the Allen Expressway for 2 hours; and

Whereas the BLMTO's Justice For Loku, Justice for Jermaine Carby, and anti-carding campaigns continue to be ongoing; and

Whereas black people are in a state of emergency; therefore

Be it resolved that the Canadian Federation of Students-Ontario endorse BLMTO's active campaigns; and

Be it further resolved that the Canadian Federation of Students-Ontario donate \$2,500 to Black Lives Matter-Toronto; and

Be it further resolved that member locals actively work in solidarity with community organizations who are working to challenge anti-black racism within their communities; and

Be it further resolved that member locals be encouraged to endorse and donate to BLMTO.
