Whereas food prices on individual campuses continue to increase; and

Whereas the rising cost of education has a severe impact on food security for students; and

Whereas Aramark Canada is known to mistreat their workers and provide a low wage and few benefits; and

Whereas there are recorded incidents of racism in the workplace and workers being assaulted by Aramark Managers, which constitutes the severe mistreatment of food service workers by Aramark Canada; and

Whereas the Canadian Federation of Students-Ontario endorsed the \$15 and Fairness campaign supporting a living wage and a fair workplace; and

Whereas food service workers have been suspended without cause for participating in the campaign for *Real Food Real Jobs* and advocating for their rights; therefore

Be it resolved that the Canadian Federation of Students-Ontario endorse the *Real Food Real Jobs* campaign; and

Be it further resolved that the Canadian Federation of Students-Ontario release a statement of solidarity with Aramark food service workers; and

Be it further resolved that the Canadian Federation of Students-Ontario provide campaign materials in support of the *Real Food Real Jobs* campaign including but not limited to buttons, posters, and pamphlets; and

Be it further resolved that member locals who have Aramark cafeterias on their campuses be encouraged to endorse this campaign; and

Be it further resolved that member locals be encouraged to publish letters directed to their administration demanding they take action on the injustice faced by Aramark food service workers.

Whereas the Federation adopted the Truth and Reconciliation Commission Calls to Action in a previous Ontario General Meeting (OGM) and makes other attempts to ensure that Indigenous students know that they are welcome to General Meetings and feel well; and

Whereas the General Meetings can be a space of emotional and spiritual exhaustion for delegates, as much as it can be physical and mental; and

Whereas many racialized and Indigenous students carry the emotional burden of intergenerational grief and lived experiences of racism and colonialism and that they bring this trauma with them to the General Meetings; and

Whereas the Ontario General Meetings make space for smudging and welcome Elders to share their knowledge and teachings, and although these reflect great strides to decolonize Ontario General Meeting proceedings, more can be done to remove the inherent colonialism that is within the Federation as an organization established on Indigenous lands and without their approval or consent; and

Whereas many delegates, as Indigenous and non-Indigenous, recognize spirituality in all aspects of their lives and turn to in search of healing and guidance; and

Whereas the inclusion of ceremonial spaces reflect the need for healing, but also for legitimizing the proceedings of Ontario General Meetings for delegates who live their lives according to their spirituality; and

Whereas an effective means in decolonizing Ontario General Meeting proceedings includes ceremony for the duration of the Ontario General Meeting that is centred on the Indigenous teachings, protocol and ceremonies of the land on which the Ontario General Meeting takes place; and

Whereas Indigenous teachings, protocol and ceremonies make space for peoples of all faiths and languages to seek guidance in ways that reflect their own spiritual teachings and protocol; and

Whereas ceremonial helpers, or those tasked with ensuring that the needs of Elders and Indigenous Knowledge Holders are met and welcoming attendees to Ceremonial Spaces, have a lot of responsibility and that the commitment required would be a burden for a delegate of a member local; therefore

Be it resolved that the Federation adopt the following "Ceremonial Space and Ceremonial Space Coordinator" in the Operations Policy:

Ceremonial Space and Ceremonial Space Co-ordinator

The Executive Committee will provide a list of Elders, ceremonial helpers and Indigenous Knowledge Holders from local Indigenous communities and organizations with due notice prior to the Meeting for the Ontario Aboriginal Constituency and Commissioner to approve and appoint.

The Executive Committee will empower the Ontario Aboriginal Constituency and Commissioner to appoint a Ceremonial Space Co-ordinator, who is a ceremonial helper. The appointment will be decided one (1) month prior to the Meeting to provide time for the Ceremonial Space Co-ordinator to fulfill their responsibilities. The Ceremonial Space Co-ordinator will provide the proper support for any Elders and Indigenous Knowledge Holders who conduct ceremony, will be responsible for communicating logistical needs for the ceremonial space to the Federation, and will respond, according to the Indigenous protocols of the territory on which the meeting takes place and with consideration of other spiritual practices, to the needs of self-identified Aboriginal delegates or staff, or any other delegates and staff who request access to the Ceremonial Space for their spiritual or mental health well-being.

Because of the responsibilities listed above require quite a bit of commitment from one individual, it is best practice that the Ceremonial Space Co-ordinator is not also a delegate representing a member local.

The Ontario Chairperson, under the guidance of the Ontario Aboriginal Constituency and Commissioner, will formally request the presence of the Elders and/or Indigenous Knowledge Holders and the Ceremonial Space Co-ordinator who were appointed.

The Federation will ensure that food is provided for the Ceremonial Space Co-ordinator and Elders, especially in instances where they cannot leave the Ceremonial Space.

The Executive Committee, under the guidance of the Ontario Aboriginal Constituency and Commissioner, will provide sufficient remuneration to the Ceremonial Space Co-ordinator, Elders, and Indigenous Knowledge Holders who attend the meeting, especially where the costs of transportation, food and accommodations are concerned.

The Ceremonial Space will be available for delegates for the duration of the Meeting and will extend beyond that time. In the spirit of beginning and ending with Ceremony and

holding space for delegates and staff who need it for their well-being, the Federation will close the Ceremonial Space after all other meeting spaces have been taken down; and

Be it further resolved that this amendment be included after "Recognition of and Respect for Unceded Traditional Territories of Indigenous People."

Whereas Indigenous students in Ontario had their first gathering in June 2016, which was successful in bringing attendees together to learn, exchange and share; and

Whereas, though successful in its mandate, the Ontario Aboriginal Gathering in June 2016 was very emotional for attendees; and

Whereas learning about colonization and colonialism can be a huge emotional burden for Indigenous students and there are not enough opportunities for healing; and

Whereas the context of Indigenous resurgence and colonialism differ in each community across Ontario and there is simply so much to learn between Indigenous communities about decolonization and Indigenous resurgence; and

Whereas Indigenous protocols and teachings indicate the importance of connecting to the local Indigenous communities when organizing events, which includes, but is not limited to, requesting land acknowledgements, opening prayers and ceremonial helpers of the community; inviting community members; and creating space for them to share their history, lived experiences, and contemporary struggles; therefore

Be it resolved that the Federation host an annual Ontario Aboriginal Gathering with the guidance of the Ontario Aboriginal Constituency Chair and the Constituency Group; and

Be it further resolved that the annual Ontario Aboriginal Gathering include opportunities for healing through ceremony, which includes, but is not limited to, sweat lodge ceremonies, sacred fires, sunrise ceremonies, full moon ceremonies and pipe ceremonies, and that these healing opportunities are organized under the guidance of the Chair and Constituency and in a way that respects the local Indigenous community and their wish for certain ceremonies to be or not be hosted in their communities; and

Be it further resolved that the location of the annual Ontario Aboriginal Gathering occur in and around different Indigenous communities near member locals with due notice and respectful protocol of the community and guidance of the Ontario Circle of First Nations, Métis and Inuit Student Constituency Group; and

Be it further resolved that the annual Ontario Aboriginal Gathering be hosted each year in the month of June to correspond with National Aboriginal History Month within Ontario and National Aboriginal Day in Canada; and

Be it further resolved that the Federation seek Elders, ceremonial helpers and knowledge holders from the local Indigenous community with due notice, active consultation, sufficient remuneration and proper protocol in organizing the Gathering, in order to centre their voices without creating undue emotional hardship.

It is recommended that this motion be considered by the Organizational and Services Development Committee.

Whereas the term "Aboriginal" is a government imposed term that has caused division within Indigenous communities/nations; and

Whereas the term "Aboriginal" is no longer used by the federal government to name First Nations, Métis and Inuit communities/nations; and

Whereas members of the Ontario Aboriginal Constituency are responsible for any name change to the constituency; and

Whereas "Indigenous" is also an umbrella term used to identify First Nations, Métis, and Inuit people; and

Whereas there are many students who self-identify as Indigenous from other communities around the world, but who are not members of First Nations, Métis or Inuit communities/nations; therefore

Be it resolved that the Ontario Aboriginal constituency be renamed the Ontario Circle of First Nations. Métis and Inuit Constituency; and

Be it further resolved that all areas of the Ontario Federation's governing documents that refer to "Aboriginal" be changed to First Nations, Métis and Inuit.

Whereas there is a lack of work that tackles this issue on our campuses and there is a need to shed light and raise awareness about xenophobia against immigrants and refugees; therefore

Be it resolved that the Federation creates educational material to challenge xenophobia and discrimination against immigrants and refugees on and off-campus; and

Be it further resolved that member locals be encouraged to include xenophobia, discrimination against immigrants and refugees in their campaigns work and find ways to engage these populations and support them on their campuses.

Whereas on December 5, 2016 during a session of the legislature, the Premier said such a standard would be created; therefore

Be it resolved that the Federation do a consultation with member locals to identify the main accessibility barriers that students attending post-secondary education are facing and to present it as part of the Federation's participation in the process.

Whereas the National Aboriginal Caucus's *Where's the Justice* campaign pillar three mandates that the Canadian Federation of Students advocate for land and water rights; and

Whereas the Canadian Federation of Students passed a motion for encouraging provincial components to support Standing Rock Sioux Tribe; and

Whereas the sacred camp site is currently well into the frigid temperatures and is in desperate need for winter shelter and camping gear to sustain the colder months; and

Whereas water protectors are planning to hold this sacred site until their lands and water rights are no longer being violated; therefore

Be resolved that the Federation stand in solidarity with the Standing Rock Sioux Tribe via letters of support, encouraging member locals to create motions that encourage support

during local rallies, donations of money, food, volunteers and supplies to the Sacred Stone camp; and

Be it further resolved that the Federation donate \$2000.00 to the Sacred Stone camp.

Be it further that the Federation coordinate with existing Palestinian activist groups to create materials about what the BDS campaign seeks to accomplish and ways in which students and community members can further the BDS campaign to continue opposing the illegal occupation of the Palestinian territories; and

Be it further resolved that research be conducted and materials be developed that educate members of corporations that invest into and profit off of Israel's illegal occupation over the Palestinian territories; and

Be it further resolved that an amount of \$2000.00 be allocated to a BDS conference with the goal of emboldening and training BDS activists province-wide, which will be organized by Palestinian activist groups in the year of 2017.

users have the ability to access, copy and redistribute original works at no additional cost and creators are still able to require attribution to mitigate commercial use"; and

Whereas the cost of tuition continues to increase and contribute to income inequality among students; and

Whereas the costs of course materials is not reasonably supported by institutional systems (including OSAP, income tax credits, "textbook" grants/bursaries); and

Whereas the demand for free education aligns equally well with the demand for free open access: therefore

Whereas Presto cards need to be tapped on a Presto card reader to activate them, which causes problems since users cannot be sure their card is loaded with money and working until they are on the bus/subway/streetcar, resulting in them being kicked off the transit unless they have backup fare if their card or the card reader is malfunctioning; and

Whereas the Presto fare system is being phased in across the TTC in stages, a process that is expected to be completed by the middle of 2017; and

Whereas post-secondary discounts for the Presto system are only currently available for MiWay and GO Transit only; and

Whereas numerous errors, glitches and technological issues have been reported regarding issues with card readers, reloading machines and other aspects of the Presto system, often resulting in users being kicked off of public transit, left to find alternative payment methods or finding alternative transportation methods; and

Whereas member locals, colleges and universities are currently working individually with local public transit to determine payment systems until Presto is fully implemented; and

Whereas the Federation has a larger circle of contacts, making it easier to communicate with larger organizations, such as the transit companies of the GTHA and Ottawa; therefore

The Ceremonial Space Co-ordinator will provide the proper support for any Elders and Indigenous Knowledge Holders who conduct ceremony, will be responsible for communicating logistical needs for the ceremonial space to Federation, and will respond, according to the Indigenous protocols of the territory on which the meeting takes place and with consideration of other spiritual practices, to the needs of self-identified Aboriginal delegates or staff, or any other delegates and staff who request access to the Ceremonial Space for their spiritual or mental health well-being.

Because of the responsibilities listed above require quite a bit of commitment from one individual, it is best practice that the Ceremonial Space Coordinator is not also a delegate representing a member local.

The Ontario Chairperson, under the guidance of the Ontario Aboriginal Constituency and Commissioner, will formally request the presence of the Elders and/or Indigenous Knowledge Holders and the Ceremonial Space Coordinator who were appointed.

The Federation will ensure that food is provided for the Ceremonial Space Co-ordinator and Elders, especially in instances where they cannot leave the Ceremonial Space.

The Executive Committee, under the guidance of the Ontario Aboriginal Constituency and Commissioner, will provide sufficient remuneration to the Ceremonial Space Co-ordinator, Elders, and Indigenous Knowledge Holders who attend the meeting, especially where the costs of transportation, food and accommodations are concerned.

The Ceremonial Space will be available for delegates for the duration of the Meeting and will extend beyond that time. In the spirit of beginning and ending with Ceremony and holding space for delegates and staff who need it for their well-being, the Federation will close the Ceremonial Space after all other meeting spaces have been taken down; and
