Whereas we should implicate and involve participants of meetings in honouring and respecting territories of the First Nation, Inuit and Métis peoples during meetings and in shared spaces; and

Whereas the Federation has committed to uphold the rights and recognition of the original

people of the territories, not just in words but also in practice in all gatherings; therefore

Be it resolved the segment on Recognition of and Respect for Unceded Traditional Territories of Indigenous People within the General Meetings Operational Policy be read as:

Respect for and recognition of the rights and land of the First Nations, Métis and Inuit peoples shall be demonstrated at all general meetings and Federation events. This will be done by acknowledging event spaces as being the traditional land of Indigenous communities and the need to respect, honour and maintain that land for future generations.

The following statement will be read aloud during the opening address at all general meetings and events with recognition of the tradition of territories on which the meeting is held:

"In recognition that there are original peoples who have experienced the ill-effects of our shared colonial past, we commit to principles of sustainability and protection of Mother Earth. We further commit to honouring and respecting the traditional territories of the First Nations in places we meet, work, learn and share space with."

Organizers must understand the experiences and ill-effects of the colonial past on original people through research and knowledge seeking, well in advance of the formal gatherings. Organizers will seek to create spaces and processes which will educate and prepare delegates and members attending meetings to be in solidarity and to display respect in honouring the traditional territories. These processes shall align with principles of sustainability mandates to protect Mother Earth.

Be it resolved that the Federation create a network of students who live in or near member local communities across the province and identify that they have the means to travel upon reasonable request to any campus events that promote hate speech; and

Be it further resolved that this network of students remain in constant communication via WhatsApp or a similar medium about event dates and locations; and

Be it further resolved that this network of students be able to meet to attend and protest these events; and

Be it further resolved that this network is not limited to Federation locals and can be extended to include and support allies on non-Federation campuses; and

Be it further resolved that the Federation release a statement condemning individual events that promote hate speech on Ontario campuses; and

Be it further resolved that the Federation designate \$1000.00 to a travel fund to support the solidarity actions of these students.

Whereas the new Ontario government recently cancelled the Prince Edward County wind project, a renewable energy project, thus makes a statement about the lack of commitment to renewable energy; and

Whereas the funds collected from the cap and trade program were to be used to fund other government operated social and infrastructure projects; therefore

Be it resolved that the Federation write a letter to the Minister of the Environment to condemn the removal of the cap and trade system, and urge the Ontario government to invest into renewable energy and initiatives; and

Whereas students have been successful in banning plastic water bottles from our campuses; and

Whereas movements such as fossil fuel divestment have been supported in the past by the Federation; and

Whereas hundreds of cities, towns, states and countries have banned plastic bags; and

Whereas river, lake, and ocean life is choking on plastic; and

Whereas over 5 trillion plastic pieces weighing over 250,000 tons are floating in the oceans according to scientific studies; and

Whereas plankton is crucially important to life on this planet, and is being overtaken by plastic and are one of the most important organisms on this planet. They have the ability to utilise the sun's rays which means they are fundamental in the earth's global productivity and produce nearly 50% of the global oxygen as a by-product. Plankton form the base of the marine food web but they are being annihilated by plastic; and

Whereas "Researchers from the Algalita Marine Research Foundation tracking marine debris in the North Pacific found that plastic flotsam was more abundant than zooplankton, the tiny (often microscopic), marine animals..."; and

Whereas an enormous number of marine animals are killed by plastic; and

Whereas we must stop using fossil fuels to avert cataclysmic climate change; and

Whereas plastic bag production relies heavily on fossil fuels from production to disposal; and

Whereas only 7-15% of plastic bags make it to recyclers. Stewardship Ontario reported a 7.2% recovery rate for plastic film in 2013 while the City of Toronto said that 15.3% of plastic bags are recycled; and

Whereas the cost of cleanup and recycling will be passed on to students in the future; and

Whereas the plastic industry manufactures plastic products but doesn't take full responsibility for the waste production; and

Whereas efforts have been made to make single-use plastic straws accessible to people with accessibility concerns, while at the same time reduction of overall consumer plastic; and

Whereas Plastic Free Guelph has developed a strategy to provide free options to those who use single-use plastic bags due to factors such as income; and

Whereas eliminating corporations wide-spread use of single-use plastic puts the responsibility on businesses rather than the individual; therefore

Be it resolved that the Federation sign on to support Plastic Free Guelph's lobby document; and

Be it further resolved that member locals are encouraged to outreach to local groups that do work against single-use plastics; and

Be it further resolved that in the effort to make single-use plastics a thing of the past, participating members acknowledge the use of single-use plastics in specific cases and make provisions in their lobbying.

Provincial emergency visits in 2017 related to opioid overdoses rose 72 per cent from 2016; and

Whereas Naloxone has proven to save lives as a short-term antidote delivered by intramuscular injection or by nasal spray to a person experiencing an opioid overdose; and

Whereas Naloxone kits (intramuscular or intranasal delivery) are available for free to individuals from local pharmacies or for purchase to organizations from local public health authorities; and

Whereas university and college orientation weeks are a time when students are at risk of overdosing on opioids; and

Whereas these orientation weeks are opportune times to educate students on drug harm reduction; and

Whereas student organizations have expressed an interest in promoting drug harm reduction to their members and to have training in naloxone administration; and

Whereas university and college orientation weeks are a time when students are at risk of overdosing on opioids; and

Whereas these orientation weeks are opportune times to educate students on drug harm reduction; and

Whereas there have been potential legal prohibitions for student unions to possess, promote or use naloxone kits which has disrupted and confused their campus harm reduction strategy; therefore

Plankton form the base of the marine food web but they are being annihilated by plastic; and

Whereas "Researchers from the Algalita Marine Research Foundation tracking marine debris in the North Pacific found that plastic flotsam was more abundant than zooplankton, the tiny (often microscopic), marine animals..."; and

Whereas an enormous number of marine animals are killed by plastic; and

Whereas we must stop using fossil fuels to avert cataclysmic climate change; and

Whereas plastic bag production relies heavily on fossil fuels from production to disposal; and

Whereas only 7-15% of plastic bags make it to recyclers. Stewardship Ontario reported a 7.2% recovery rate for plastic film in 2013 while the City of Toronto said that 15.3% of plastic bags are recycled; and

Whereas the cost of cleanup and recycling will be passed on to students in the future; and

Whereas the plastic industry manufactures plastic products but doesn't take full responsibility for the waste production; and

We further commit to honouring and respecting the traditional territories of the First Nations in places we meet, work, learn and share space with."

Organizers must understand the experiences and ill-effects of the colonial past on original people through research and knowledge seeking, well in advance of the formal gatherings. Organizers will seek to create spaces and processes which will educate and prepare delegates and members attending meetings to be in solidarity and to display respect in honouring the traditional territories. These processes shall align with principles of sustainability mandates to protect Mother Earth.

Whereas Toronto's Medical Officer of Health Dr. Eileen de Villa issued a statement saying scientific literature and studies have concluded that both overdose-prevention and safe injection sites save lives; and

Whereas Nick Boyce, director of the Ontario HIV & Substance Use Training Program has stated "There is overwhelming evidence from experts and from other jurisdictions around the world that supervised consumption sites save lives and help people dealing with addiction connect with other types of support when they are ready"; and

Whereas over 1200 Ontarians died of preventable opioid overdoses in 2017; therefore

Be it resolved that the Federation write a letter to the Premier, the Minister of Health, as well as the leaders of the NDP, Liberal and Green Parties and their Health critics urging the province to immediately lift the moratorium on approving new overdose prevention sites and urging the province to increase support for overdose prevention, safe injection and other opioid use harm reduction initiatives; and

Be it further resolved that the Federation make a public statement to this effect; and

Be it further resolved that member locals be encouraged to write similar letters and make similar statements.

Whereas people on very low income and those with disabilities in Ontario have chronically been prevented from pursuing post-secondary education due to interdependent social, economic and bureaucratic barriers; and

Whereas despite the odds, 3314 recipients of the Ontario Disability Support Program (ODSP) as of 2015-2016 received the Ontario Student Assistance Program (OSAP) funding for full-time studies in Ontario's publicly-funded post-secondary institutions; many or most of these students were Federation members; and

Whereas the number of ODSP recipients currently in post-secondary school full-time is likely close to, or more than 3314; and

Whereas there are an uncalculated number of ODSP recipients who are attending part-time post-secondary education, many or most of whom are also Federation members; and

Whereas the sudden and unexpected reversal of the province's commitment to implement further recommendations from the pre-established policy document "Roadmap for Change" for those on social assistance is creating great fear in recipients, will create increased financial hardship for them and put their plans for post-secondary education in jeopardy; and

Whereas several people in the Basic Income Pilot are attending post-secondary school or were in the process of enrolling; many or most of whom are thus Federation members; and

Whereas the Ford government chose to reverse their commitment to continue the Basic Income Pilot for its planned three-year assessment period, leaving the participants' plans such as post-secondary education in chaos; and

Whereas multiple studies concur that the more education people receive, the less they rely on social assistance as their employability improves, in keeping with the Ford government's goals for social assistance reform; therefore

Be it resolved that the Federation issue a statement of support for those organizations lobbying to reverse the announced cancellation of improvements to ODSP and Ontario Works (OW) and a statement of support for advocates of the Basic Income Pilot; and

Be it further resolved that the Federation make an in-kind donation to the ODSP-Action Coalition to support their lobbying efforts.
